SUCAM

Selection - Use - Care - And - Maintenance

- SUCAM documents are not available for all applications (see available documents on the right)
- Documents are very complex and should be more user-friendly
- Directives for manufacturers and users:
 - Regulation 2016/425- personal protective equipment
 - Directive 89/656/EEC use of personal protective equipment
- Regulation (EU) 2016/425 on PPE does not consider the treatment (textile service) or the wearer
