### EU Legislation and PPE

Regulation EU 2016/425

#### Challenges for SMEs:

#### Article 47:

Products in conformity with the Directive can be still placed on the Market until 20 April 2019.

Products already in the distribution chain by that date, can be sold after that date.

# NEW EU REGULATION FOR PERSONAL PROTECTIVE EQUIPMENT: WHAT DOES IT MEAN FOR EUROPEAN SMES?



As a manufacturer, does this mean that I must retest all my products?

No. Certificates and approval decisions issued under the PPE Directive, before 21 April 2019, remain valid also for providers and suppliers (e.g. laundries, rental companies, dealers, textile services) until 21 April 2023 unless they expire before that date.


